- 1. A well filled in Pre-qualification Form A
- 2. A price list of the goods or services.
- 3. Company profile.
- 4. A copy of valid trading license.
- 5. A copy of VAT registration certificate.
- 6. Tax identification Number (TIN).
- 7. Certificate of Corporation and Registration.

Pre-qualification requirements for Individual Proprietors

Competing Individual Proprietors must attach the following

- 1. A well filled in Pre-qualification Form **B**
- 2. Personal profiles.
- 3. Copies of previous works.
- 4. Curriculum vitae/resume.
- 5. Recommendations from at least three of their recent clients.
- 6. Copy of Official Identification (Passport / National ID).

- Interested bidders should download and fill either <u>FORM 'A'</u> for registered entities or <u>FORM 'B'</u> for Individual proprietors.
