About Food Rights Alliance (FRA)

Food Rights Alliance is a coalition with over 40 members spread out in all regions of Uganda. It's driven by a vision of a world free from hunger and malnutrition and promotes a mission; to promote the realization of the right to food in Uganda through strengthening sustainable farming systems and improving food and nutrition Justice.

FRA achieves her mission through a number of strategies, including; building a formidable, strong in numbers, competence and diversity network of members and stakeholders that influences policy and practice at different levels; Developing and profiling champions on critical issues of the agenda of realizing the right to adequate food, equipped with knowledge and information and credible to flag the agenda in policy and practice.

FRA is implementing a 1 year and 8 months project Funded by HIVOS. The project seeks to enhance integrated agricultural sector investment planning for improved nutrition and sustainable diet.

The project envisions the need to influence policy on nutrition but also enhance nutritious dietary intake to boost people's immune system.

Under this project, FRA intends to, create an online interactive platform for food and nutrition actors to dialogue on emerging issues e.g. pandemics and how to prepare for them.

Background:

The lingering nutritional gaps in the country are caused by both knowledge gap and policy related factors. The country has developed a cobweb of policy frameworks on food and nutrition and investment plans among others. However, national and household food security and nutrition has never attracted the full attention of the political leadership in terms of duty and obligation. Therefore, the status of agriculture, Food and nutrition at the higher levels of planning have been with more assumption than outcome designed orientation. The advent of COVID 19 crisis is rapidly exacerbating an ongoing food security and nutrition crisis in Uganda. In a matter of weeks, COVID-19 has revealed the importance of nutrition in national food systems.

The current situation when the world is faced with COVID 19 that has halted physical meetings, it's important that stakeholders find a virtual platform to share ideas, experiences across borders in order to strategize together on how to use nutrition security to strengthen community's immunity not to be threatened by such pandemics but also promote a recovery



should the pandemics re-occur. Further they will strategize on how to influence government to prioritize food and nutrition security in her future programming and planning. For this to happen, there is need to have a channel through which stakeholders can exchange, share ideas concerning nutrition security since all are working at different levels, it's through sharing that they will come up with common messages to use to influence polices.

The purpose of this assignment therefore is to develop an online platform that will be used by stakeholders to share ideas among themselves in a bid to boost community immune system through knowledge sharing.
